<p>Violation #34. Plumbing Repair leak at the three compartment sink Repair leak from faucet at the three compartment sink CODE REFERENCE: Plumbing. 64E-11.007(3). Plumbing will comply with the plumbing authority having jurisdiction. Backflow prevention will be provided where needed.</p>
<p>Violation #36. Handwashing facilities Repair soap dispenser at handwashing sink in the kitchen CODE REFERENCE: Handwash Sinks. 64E-11.007(5). Handwash facilities will be located in employees' restrooms, food prep areas, and in mechanical dishwash areas.</p>
<p>Violation #39. Other facilities and operations Repair both serving lines. However, facility has multiple ovens and warmers that are being used to keep the food warm until it's serving time CODE REFERENCE: Other Facilities. 64E-11.008. Floors, walls, and ceilings shall be smooth and washable. 20 foot candles of light shall be provided. Adequate ventilation shall be provided. A mop sink or garbage can wash down will be provided. No living quarter shall open to the facility. No live animals. Exterior area shall be kept clean.</p>
